All that certain lot or parcel of land situate in the County of Lake, State of Indiana, and being more particularly described as follows:

BEING KNOWN AND DESIGNATED as part of Outlot 1 as shown on the recorded plat of Pratt and Reuschill's Subdivision, in the City of Crown Point, recorded in Plat Book 1, Page 8 in the Office of the Recorder of Lake County, Indiana, described as follows:
