## LEGAL DESCRIPTION

Parcel I: Part of the West Half of the Northwest Quarter of the Southwest Quarter of Section 35, Township 36 North, Range 8 West of the 2nd Principal Meridian, in the City of Hobart, Lake County, Indiana, described as follows: Beginning at the Southeast corner of said Half Quarter-Quarter Section; thence West, on the South line thereof, 205 feet to the East line of the permanent right of way of Interstate Route 65; thence North 18 degrees 08 minutes 46 seconds East along said right of way 287.19 feet; thence North 17 degrees 16 minutes 45 seconds East along said right of way line 200.25 feet; thence North 20 degrees 08 minutes 30 seconds East along said right of way line 164.95 feet to the East line of said Half Quarter-Quarter section; thence South on said East line 619.55 feet to the point of beginning.

Parcel II: The East Half of the Northwest Quarter of the Southwest Quarter of Section 35, Township 36 North, Range 8 West of the 2nd Principal Meridian, in the City of Hobart, Lake County, Indiana, except that part in the Northwest corner taken for Interstate Highway I-65.
