More commonly known as 4338 S Sheffield Ave, Hammond, IN 46327-1318

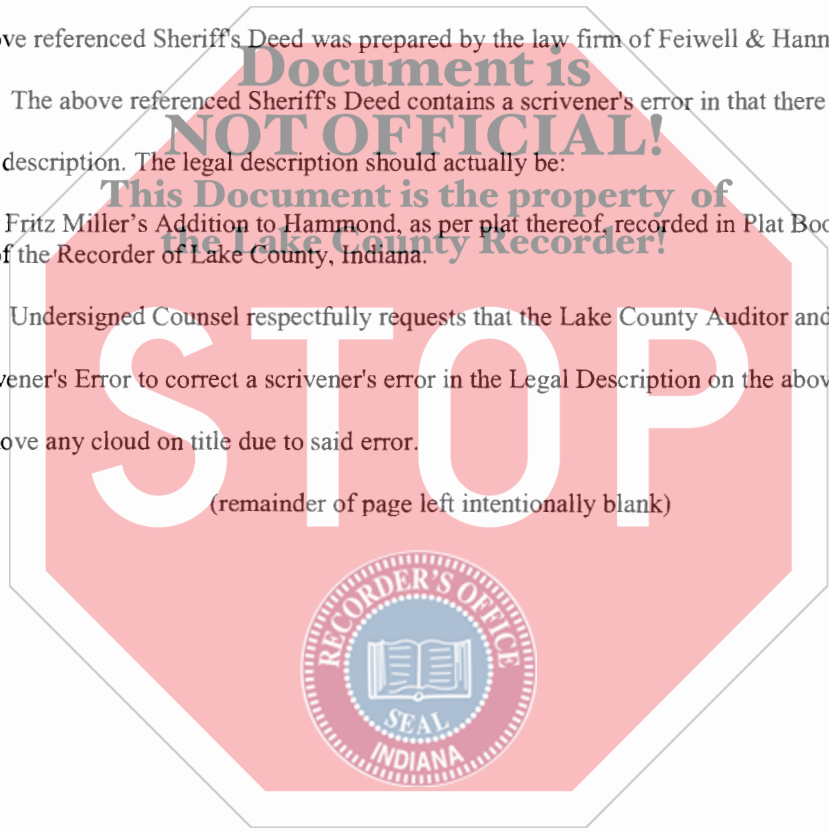

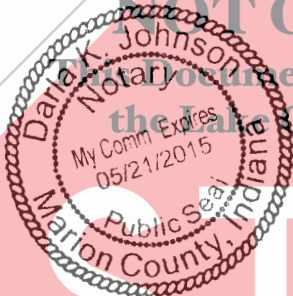
