BOARD RESOLUTION NO. 654

A RESOLUTION AUTHORIZING AN INTERLOCAL COOPERATION AGREEMENT FOR EADS ELEMENTARY SCHOOL/MUNSTER PARKS AND RECREATION PLAYGROUND PROJECT

WHEREAS, the Board of School Trustees (the "Board") of the School Town of Munster (the "School") and the Munster Board of Parks and Recreation (the "Park") seek jointly to develop, equip and maintain a playground facility at Eads Elementary School for the benefit of the students of the School and the residents of the Town of Munster (the "Town"); and,

WHEREAS, Indiana Code §36-1-7-1 et seq. allows local government entities to make the most efficient use of their powers by enabling them to mutually purchase and utilize equipment and supplies for the mutual benefit of each other; and,

WHEREAS, the School and the Park are signatories an Interlocal Cooperation Agreement dated December _____, 2009 regarding a playground equipment project; and,

WHEREAS, the School and the Park desire to better provide and utilize resources, equipment and services for the mutual benefit of the participating entities and at a shared cost.

NOW, THEREFORE, BE IT RESOLVED by the Board of School Trustees of the School Town of Munster, Lake County, Indiana as follows:

1. That the Board approve the Interlocal Cooperation Agreement for Eads Elementary School between the School and the Park.
2. That the President and Secretary of the Board are authorized to sign the Interlocal Cooperation Agreement for Eads Elementary School/Munster Parks and Recreation Playground Project, a copy of which Agreement is attached to the Resolution and incorporated herein by reference.
3. That the Resolution shall take effect and be in full force from on and after its passage by the Board of Parks and Recreation of the Town of Munster, Lake County, Indiana, and after its passage by the School Town of the Town of Munster, Lake County, Indiana.
4. That any and all actions taken prior to the date of this Agreement be ratified and approved.

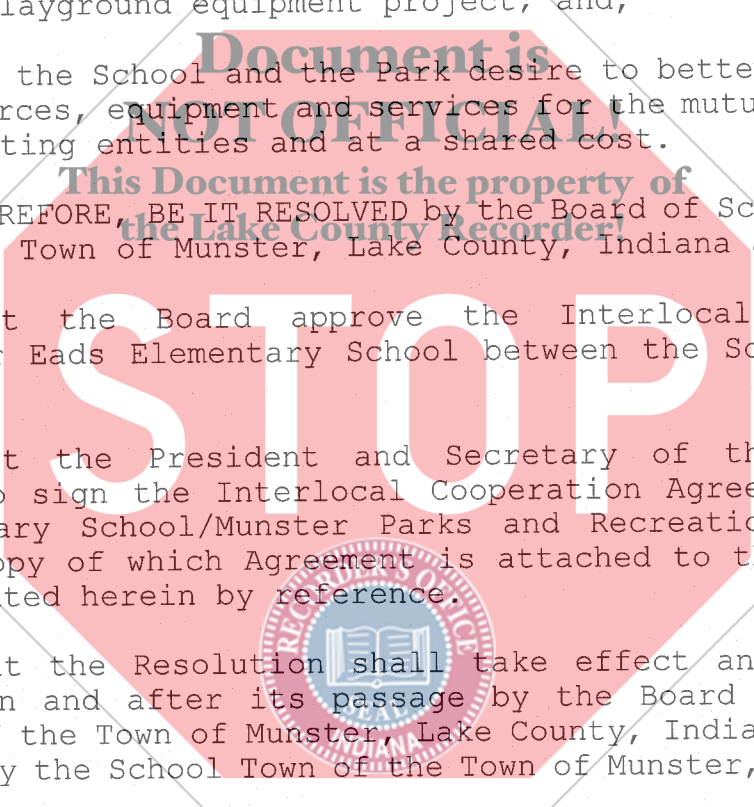
