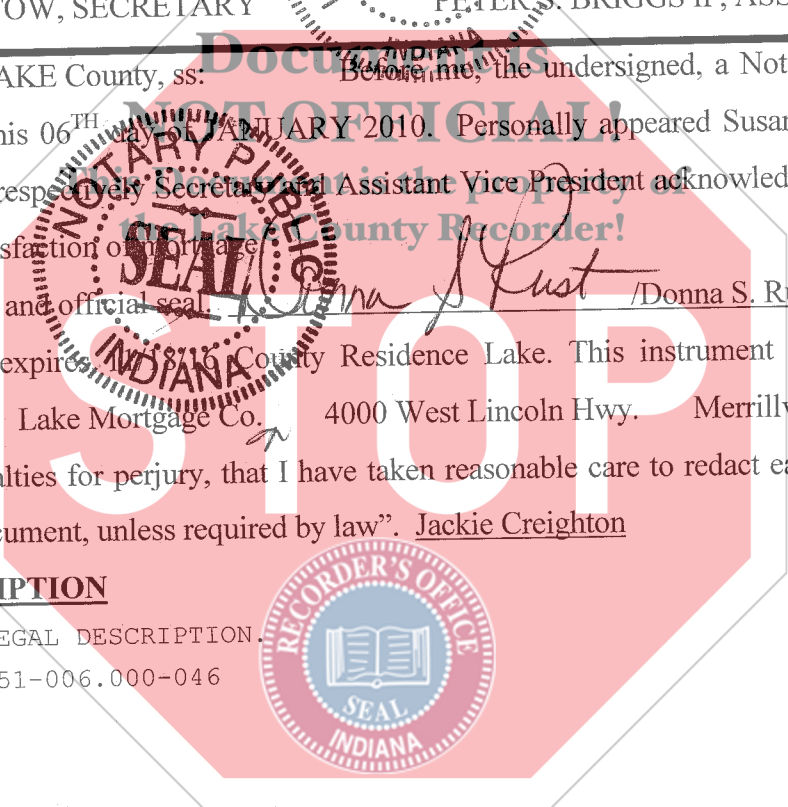

All that part of the East Half of the Southwest Quarter of the Southeast Quarter of Section Twenty-four Township Thirty-five North, Range East West of the 2<sup>nd</sup> P.M. lying North of the center line of the Public Road, being more particularly described as follows: Commencing at the Northeast corner of the East Half of the Southwest Quarter of the Southeast Quarter of said Section Twenty four; thence West along the North line of said East Half of the Southwest Quarter of the Southeast Quarter to the Northwest corner thereof; thence South along the West line of said East Half of the Southwest Quarter of the Southwest Quarter a distance of 270.50 feet to the center line of the public road; thence in a Northeasterly direction along the center line of said public road a distance of 591.94 feet, to a point which is, 100 feet West of the East line of the East Half of the Southwest Quarter of the Southeast Quarter of said Section Twenty-Four; thence continuing East along said center line of said road a distance of 100 feet to the East line of the East Half of the Southwest Quarter of the Southeast Quarter; thence North 79.51 feet to the place of beginning, in Lake County, Indiana containing 2.433 acres, more or less.
