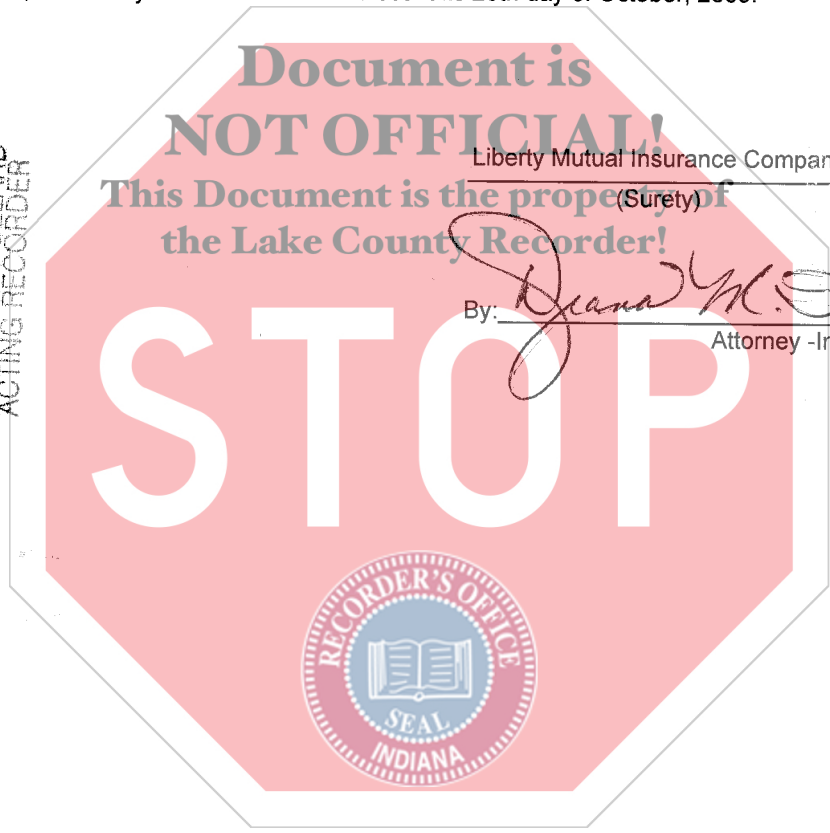

ARTICLE XIII - Execution of Contracts: Section 5. Surety Bonds and Undertakings.

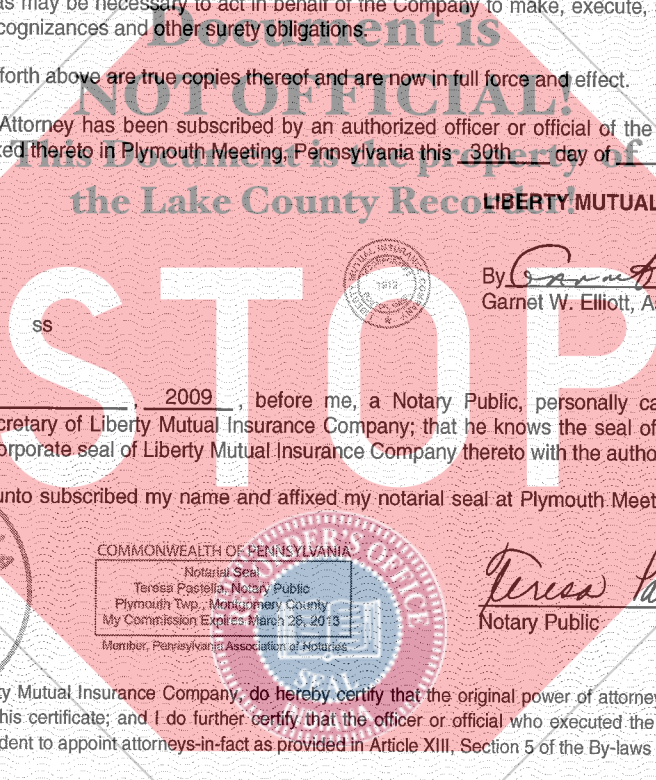

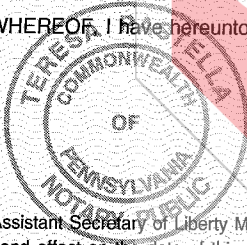
