**QUITCLAIM DEED**

**THIS INDENTURE WITNESSETH**, That **Robert Greathouse and Evelyn Greathouse**, husband and wife (hereinafter designated as the "Grantors"), for One Dollar (\$1.00), quitclaim to **Gerald L. Greathouse** (hereinafter designated as the "Grantee"), an undivided one-third (1/3) interest in the following legally described real estate in Lake County, in the State of Indiana:

Part of the West 160 acres lying South of the centerline of the Brown Ditch and North of the South 120 rods of Section 7, Township 32 North, Range 7 West of the Second Principal Meridian, in Lake County, Indiana, more particularly described as follows:

Beginning at the intersection of the West line of said Section 7 and the center line of the Brown Ditch; thence Northeasterly along the center line of Brown Ditch a distance of 322 feet, more or less, to the center line of a ditch running in a Northerly and Southerly direction; thence Southerly along the center line of said ditch a distance of 860 feet, more or less, to a point; thence West at right angles to the West line of said Section 7, a distance of 360 feet, more or less, to the West line of said Section 7; thence North along the West line of said Section 7, a distance of 809 feet, more or less, to the place of beginning.

After this conveyance, Grantors own an undivided 1/3 interest in said real estate and Grantee owns an undivided 2/3 interest in said real estate.

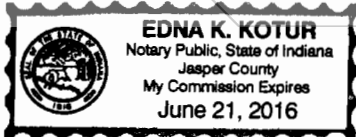
