Comes now MARTHA A. FISH, being duly sworn upon her oath, and states as follows:

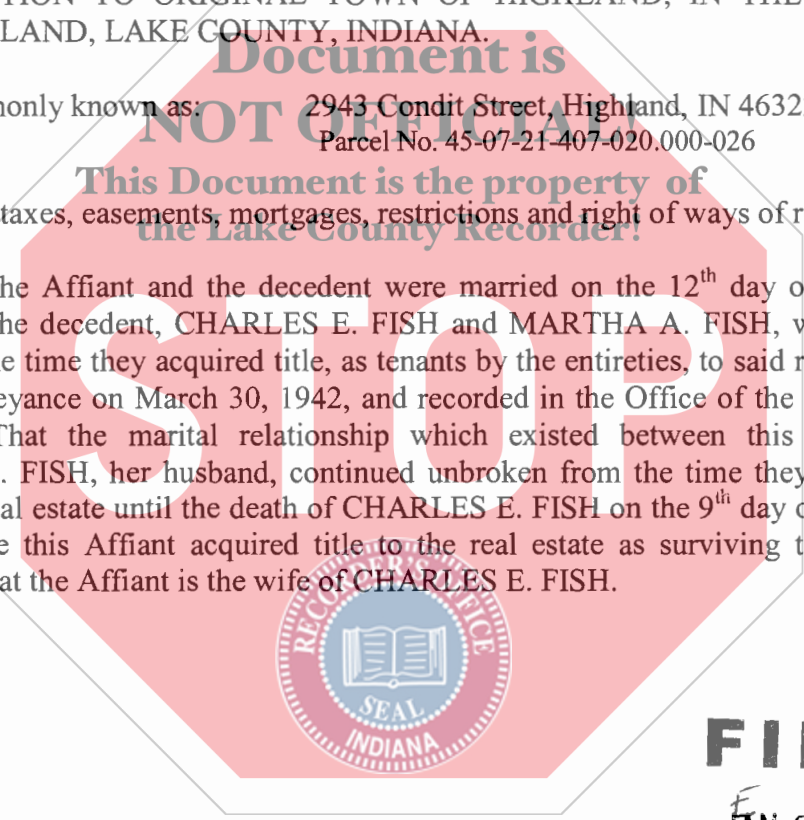
That MARTHA A. FISH is the owner in fee simple of the following real estate located in Lake County, Indiana, more particularly described as follows:
