- 5. Clarence E. Tillotson and Louise Tillotson were husband and wife at the time they obtained title to said real estate and remained as husband and wife until the time of death of Clarence E. Tillotson. They were never divorced.

- 10. Said Order vested title to said real estate in Marion Penick, Jr., the sole legatee and devisee under the Last Will and Testament of Louise E. Tillotson.
- 11. Marion Penick, Jr. has personal knowledge of all the facts alleged in this affidavit because he was the personal representative of the estate of Louise E. Tillotson.
- 12. The purpose of this Affidavit is to induce the Lake County Auditor's Office to show Marion Penick, Jr. as the sole owner of said real estate on the Auditor's Transfer record, and to place of record with the Lake County Recorder's Office evidence that Marion Penick, Jr. is the sole owner of said real estate.


