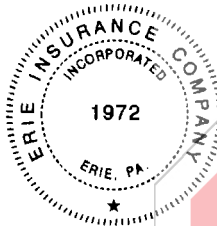
POWER OF ATTORNEY

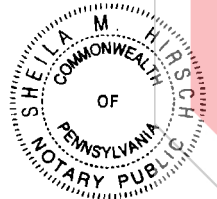

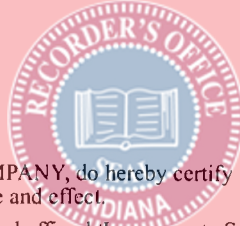
