2. That my husband, Martin Siersema, died on January 22, 2010, leaving me, Beatrice Siersema, as his widow, never having filed for or having been divorced.

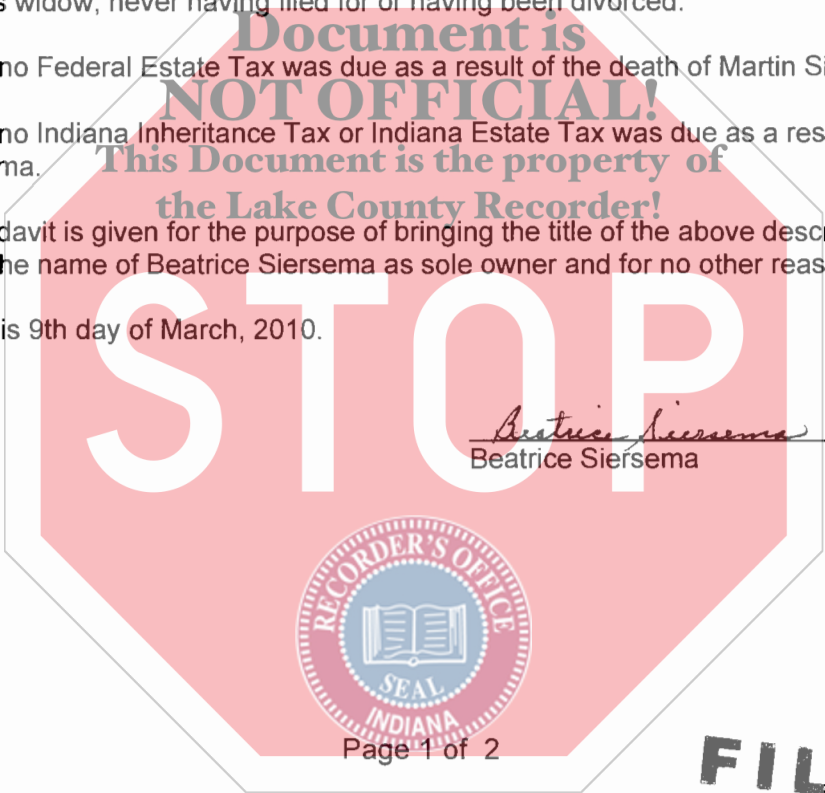
3. That no Federal Estate Tax was due as a result of the death of Martin Siersema.

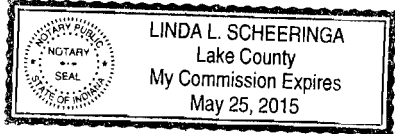




