This release shall not affect the lien of said mortgage as to the remainder of the premises described therein and not hereby specifically released.

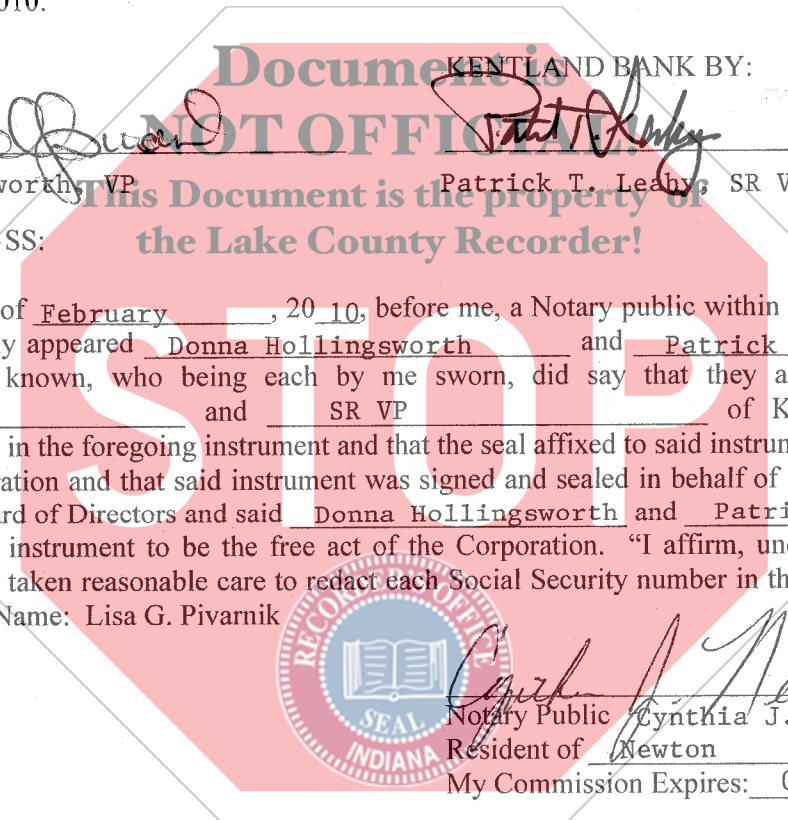
