

RELEASE OF MORTGAGE

The undersigned, Timothy P. Kors, hereby certifies that the mortgage, dated October 6, 1993, executed by Kenneth D. Kors, as Trustee under the terms and conditions of that certain written agreement and declaration of trust dated August 16, 1993, as mortgagor, to Timothy P. Kors, as mortgagee, and recorded on October 14, 1993, as Document No. 93067559, in the County of Lake, State of Indiana, together with the debt secured by said mortgage, has been fully paid, satisfied, released, and discharged, and that the property secured thereby has been released from the lien of such mortgage.

Bridge, Commissioners and approved by said Court on November 5, 1902; said lot being described as part of the East 1/2 of Section 24, Township 36 North, Range 10 West of the 2nd Principal Meridian, commencing at a point which bears South 76 degrees 52 minutes East and a distance of 471.36 feet from the Southwest corner of the 13.79 acre tract, which was deeded by Jochin Grugel and others to James Walsh and which is recorded on Plat 544, Book 33 of records of deeds, of Lake County, Indiana; thence South 2126.07 feet to the South line of a tract of land owned by Jochin Grugel; thence South 80 degrees 45 minutes East 211.22 feet; thence North 2111.40 feet to the South line of said Walsh tract; thence North 76 degrees 52 minutes West 213.94 feet to the place of beginning, in Munster, Lake County, Indiana, said part being described as follows: Beginning at the Northwest corner of said Lot "C"; thence South 76 degrees 52 minutes East along the North line of said Lot "C", 100 feet; thence South 0 degrees 55 minutes East along a line parallel to and 97.01 feet due East of the West line of said Lot "C" a distance of 898.05 feet; thence North 76 degrees 52 minutes West 100 feet to the West line of Lot "C"; thence North 0 degrees 55 minutes West 898.05 feet to place of beginning.

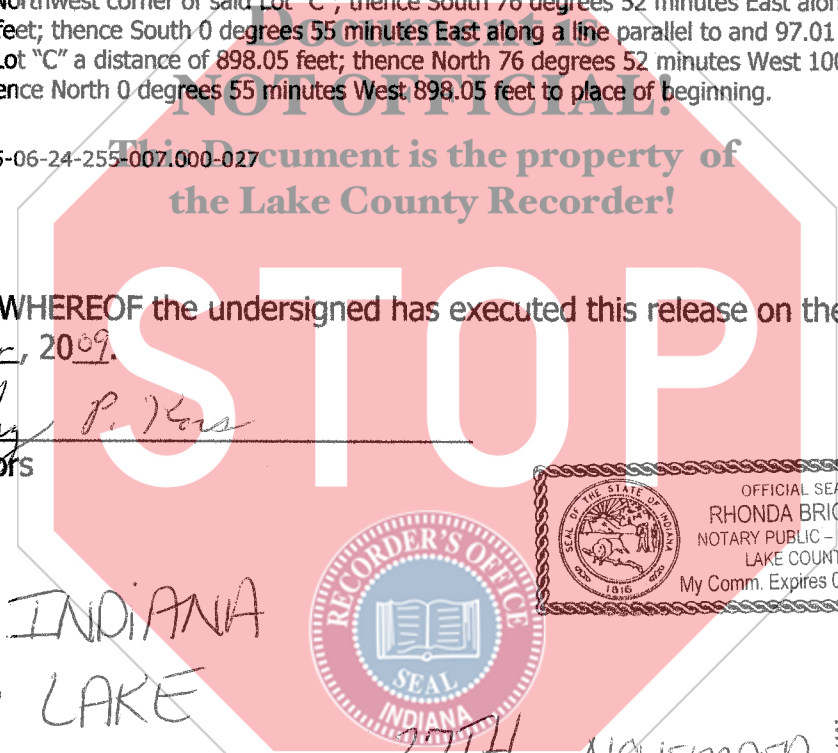
