**MEMORANDUM OF RESTATEMENT OF THE
HOMEIER LIVING TRUST**

1. On February 22, 2010, I Restated my Trust, known as the Homeier Living Trust, "Trust", which was originally executed on October 25, 1990.

2. In reliance upon the terms and conditions of my original Trust, the following described real estate was transferred into the name of the Trustees of the Trust, to-wit:

Part of the Southeast Quarter of the Southwest Quarter of Section 8, Township 34 North, Range 8 West of the 2nd Principal Meridian, in the City of Crown Point, Lake county, Indiana, described as follows: Beginning at a point 107.93 feet Southwesterly measured along the center line of Court Street from a point which is 514.14 feet North and 803.88 feet West of the Southeast corner of said ¼ ¼ Section; thence Southwesterly along the center line of said Court Street a distance of 56.41 feet; thence East 227.60 feet; thence North 55.70 feet more or less, to the Southeast corner of a tract of land conveyed in 1948 by Deed recorded November 17, 1948 as Document Number 372002 in Deed Record 825 page 218 in the Recorder's Office of Lake County, Indiana; thence West, along the South line of said tract of land conveyed in Deed Record 825 page 218, a distance of 213.33 feet to the center line of Court Street and place of beginning.




