JUDGEMENT QUIETING TITLE TO REAL ESTATE

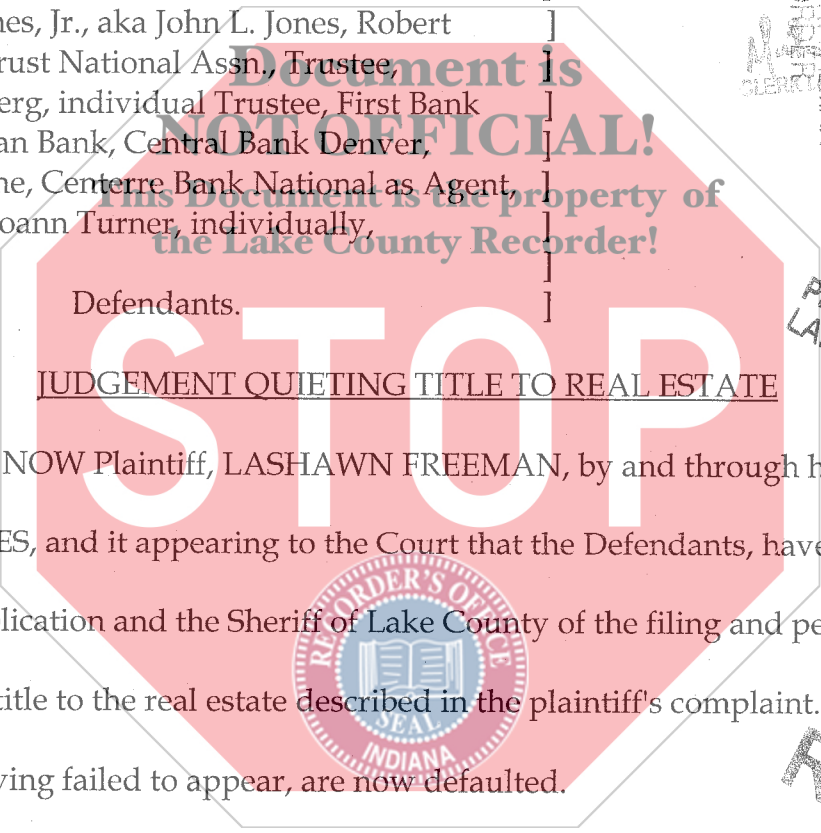

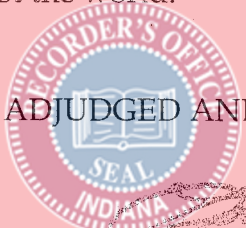
