792 W. 181st AVENUE, LOWELL, IN 46356

Part of the West Half of the Southeast Quarter of Section 21, Township 33 North, Range 8 West of the Second Principal Meridian in Lake County, Indiana, more particularly described as follows: Commencing at the Southwest corner of said West Half of the Southeast Quarter; thence North 89 degrees 55 minutes 49 seconds East along the South line of said Southeast Quarter a distance of 250.00 feet to the Point of Beginning; thence continue along said south line North 89 degrees 55 minutes 49 seconds East a distance of 263.46 feet; thence North 02 degrees 42 minutes 40 seconds West a distance of 390.31 feet; thence South 89 degrees 55 minutes 49 seconds West parallel with the South line of said West Half of the Southeast Quarter a distance of 254.71 feet; thence South 01 degrees 25 minutes 42 seconds East parallel with the West line of said West Half of the Southeast Quarter a distance of 390.00 feet to the Point of Beginning, containing 2.32 acres
