

LAST WILL and TESTAMENT 45D01-1007E N 5 2

OF

L. COSBY BERNARD

I, L. COSBY BERNARD, of Lancaster County, Virginia, declare this to be my will, and I revoke all prior wills and codicils that I have made.

ARTICLE I

A. In the trust instrument referred to in Article VI of this will, I have directed the trustee to provide for payment of all of (a) my legally enforceable debts, including debts owed by me to a trustee individually, except debts which constitute a lien or encumbrance on real property, (b) the expenses of my last illness and funeral, (c) the administration expenses payable by reason of my death, and (d) the estate, inheritance, and other death taxes (including interest and penalties, if any, but excluding any generation-skipping tax) payable in any jurisdiction by reason of my death (including those administration expenses and death taxes payable with respect to assets which do not pass under that trust instrument) other than that part of any such death taxes attributable to property in which I have a qualifying income interest for life or over which I have a power of

appointment and with respect to which my Executor shall be entitled to reimbursement or recovery. My Executor shall enforce all rights to reimbursement for or recovery of, and provide for payment of, any such death taxes attributable to property in which I have a qualifying income interest for life or over which I have a power of appointment, unless payment of such estate tax has otherwise been satisfactorily provided for out of the qualifying income interest for life or power of appointment property.

B. If my wife predeceases me and establishes a QTIP Trust in which I am the beneficiary of the income from that trust in at least annual payments, I direct that any taxes payable on my death as the result of funds placed in that QTIP Trust be paid out of my estate.

C. Despite the provisions of paragraph A of this Article, my Executor shall pay the amount of those debts, expenses, and death taxes referred to in paragraph A of this Article directed to be paid by the trustee but certified by the trustee as exceeding the principal out of which the trustee is directed to provide for payment. Any such amount payable by my Executor because of any such certification by the trustee shall be paid out of and charged generally against the principal of my residuary estate without seeking reimbursement or recovery from any person.

ARTICLE II

I have left separate instructions as to the disposition of my remains and as to a memorial and direct that the cost of these expenses be paid as set out in Article I as soon as practicable.

ARTICLE III

I was formerly married to Ann E. Flanagan but was divorced from her. I am married to Joyce Anne Bernard, hereinafter referred to as "my spouse" and have three children who are now living, whose names are Leslie C. Brosshart, currently residing at 222 Rutgers Ave., Swarthmore, PA 19081, Stuart C. Bernard, currently residing at 3407 S. Chestnut, Broken Arrow, OK 74012, and Sydney Bernard-Hogling, currently residing at 31467 Upper Bear Creek Road, Evergreen, CO 80439.

ARTICLE IV

A. I give all the tangible personal property which I own at my death, including any household furniture and furnishings, automobiles, books, pictures, jewelry, art objects, hobby equipment and collections, wearing apparel, and other articles of household or personal use or ornament, to my spouse, if my spouse is living on the thirtieth day after the date of my death, or if my spouse is not then living, to Leslie C. Brosshart, Stuart C. Bernard and Sydney Bernard-

Hogling as are living on the thirtieth day after the date of my death, in shares of substantially equal value, to be divided in such manner as they shall agree or, if they shall fail to agree upon a division within six months after the date of my death, as my Executor shall determine. I may leave a list or lists disposing of certain items of tangible personal property not otherwise specifically bequeathed, and the lists will be signed by me. It is my intention that these dispositions be made to the named persons by my executor as such dispositions have been given effect by Virginia law.

B. All costs of safeguarding, insuring, packing, and storing my tangible personal property prior to its distribution and of delivering each item to the place of residence of the beneficiary of that item shall be the expense of my estate.

ARTICLE V

I give all my residuary estate, being all property, real or personal, wherever situated, in which I may have any interest at my death not otherwise effectively disposed of, but not including any property over which I have power of appointment, to the acting trustee or trustees of that certain trust already created by me and known as the L. COSBY BERNARD REVOCABLE TRUST DATED SEPTEMBER 20, 2002, as in effect at my death, of which I and my spouse are now are trustees.

ARTICLE VI

- A. I name my spouse to serve without surety or other security on any bond as Executor. I name C. Dwight Clarke as successor executor.
- B. If the appointment of an Executor of my estate is necessary or desirable in any jurisdiction in which no Executor herein named is able and willing to act, I appoint as my Executor in that jurisdiction such person (who may be an officer or employee of a corporate Executor then acting) or corporation as may be designated in an instrument signed by my spouse, if legally competent, otherwise by my Executor to serve without bond, or if bond is required, without surety thereon, and to have all the powers and discretion with respect to my estate in that jurisdiction that are set forth or referred to in paragraph C of this Article, to be exercised without court order. As used in this will, the term "Executor" means any court-appointed fiduciary of my estate from time to time qualified and acting in any jurisdiction.
- C. In addition to any powers granted by law, I give my Executor power, exercisable in the discretion of my Executor and without court order, to retain, sell (at public or private sale), exchange, lease for any term (even though commencing in the future or extending beyond the date of final distribution of my estate), mortgage, pledge, or otherwise deal for any purpose with the property, real or personal, from time to time

comprising my estate, for such consideration and on such terms (with or without security), as my Executor shall determine; to borrow money for any purpose, at interest rates then prevailing, from any individual, bank, or other source, irrespective of whether that lender is then acting as Executor; to invest in any property whatsoever; to compromise or abandon any claims in favor of or against my estate; to hold any property in the name of a nominee or in bearer form; to employ accountants, depositaries, attorneys, and agents (with or without discretionary powers); to execute contracts, notes, conveyances, and other instruments, including instruments containing covenants and warranties binding upon and creating a charge against my estate, and containing provisions excluding personal liability; to make distributions wholly in cash or in kind, or partly in each; to allot different kinds or disproportionate shares of property or undivided interests in property among the beneficiaries; and to determine the value of any property distributed in kind.

D. I direct my Executor to make such elections under the tax laws as my Executor deems advisable, including an election to create qualified terminable interest property, without regard to the relative interests of the beneficiaries, and my Executor shall have no liability for, or obligation to make compensating adjustments between principal and income or in the interests of the beneficiaries by reason of, the effects

of those elections. Any decision made by my Executor with respect to compensating adjustments or the exercise of any tax election shall be binding and conclusive on all persons.

E. I direct that the compensation of the corporate Executor, if any, shall be in accordance with its published schedule of fees as in effect at the time the services are rendered.
