SWORN STATEMENT OF INTENTION TO HOLD LIEN

The undersigned, being first duly sworn, makes this sworn statement of intention to hold a lien upon the property described below and says that:

1. The undersigned, Lake Dalecarlia Property Owners' Association, Inc., an Indiana Corporation, 4665 Main, Lowell, Indiana, 46356, intends to hold a lien on land legally described as follows:

- Parcel 1: Lots 14, 15 and 18, Block 35, in Dalecarlia, as shown in Plat Book 24, Page 1 in Lake County, Indiana.
- Parcel 2: Part of Lot "N", Block 16, in Dalecarlia, as shown in Plat Book 22, Page 18, In Lake County, Indiana, being that part of said lot "N" lying Northerly of a line described as follows: Beginning at the Southwest corner of Lot 18, in Block 35, in Dalecarlia (Blocks 35 to 38, inclusive), as shown in Plat Book 24, page 1, in the Office of the Lake County Recorder; thence Southwesterly along the Southerly line of said Lot 18, extended 69 feet, more or less, to the Southwesterly line of Lot "N", and the terminus of said line.
- Parcel 3: Lot "M", Block 16, in Dalecarlia, as shown in Plat Book 22, Page 18, in Lake County, Indiana, except that part described as follows: Beginning at the Northwesterly corner thereof; thence Southwesterly 100 Feet to the Southwesterly corner thereof; thence Southeasterly of the Southerly line thereof, 100 feet; thence Northeasterly 36.7 feet to the East line of said Lot "M"; thence North on the East line of said Lot "M", 88.5 feet to the Northeasterly corner thereof; thence Northwesterly 46.5 feet to the place of beginning; as well as on all buildings, other structures and improvements located thereon or connected therewith.
