Hayden Trust dated 9-26-78, the receipt of which is hereby acknowledged, does hereby waive the priority of the lien it now has by virtue of being the owner and holder of a promissory note secured by a real estate mortgage dated March 30, 2005 executed by in the sum of \$ 803,161.45, to Farm Credit Services of Mid America, PCA,

which mortgage was filed for record on April 11, 2005 and recorded in Mortgage Book Document #2005 028110 in the Recorder's Office of Lake County, Indiana,

Nothing in this instrument shall be construed to affect the validity of the above-described mortgages and said mortgages shall remain in full force and effect.

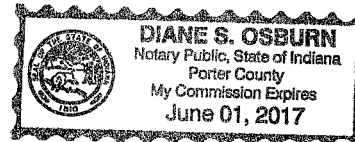
