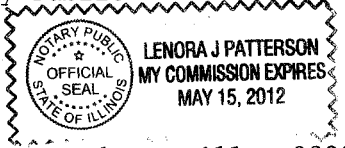

## LEGAL DESCRIPTION

Commencing at the Southeast corner of said Lot 6; thence South 53 degrees 00 minutes 00 seconds West, 49.95 feet to the point of beginning of this described parcel; thence continuing South 53 degrees 00 minutes 00 seconds West, 31.04 feet; thence South 74 degrees 23 minutes 26 seconds West, 3.44 feet; thence North 16 degrees 58 minutes 36 seconds West, 111.7 feet, more or less, to the Northerly line of said Lot 6; thence Easterly along the Northerly line of said Lot 6, a distance of 32.74 feet; thence South 16 degrees 58 minutes 36 seconds East, 103.92 feet, more or less, to the point of beginning.
