**MEMORANDUM OF RESTATEMENT OF THE**  
**SCHUETT LIVING TRUST AND AFFIDAVIT OF SURVIVORSHIP**

TAX KEY NO. 45-16-21-126-005.000-041, 12520 Polk Street, Crown Point, IN 46307

1. October 04, 2010, I Restated my Trust, known as the Schuett Living Trust, "Trust", which was originally executed on January 11, 1995.

2. In reliance upon the terms and conditions of my original Trust, the following described real estate was transferred into the name of the Trustee of the Trust, to-wit:

Part of the Northwest ¼ of the Northeast ¼ of the Northwest ¼ of Section 21, Township 34 North, Range 8 West of the 2nd Principal Meridian, more particularly described as follows: Beginning at a point on the West line of the Northwest ¼ Northeast ¼ Northwest ¼ of said Section 21 said point being 198.8 feet North of the Southwest corner thereof; thence North along said West line a distance of 164 feet; thence Southeasterly with an interior angle of 79 degrees 32 minutes a distance of 375.45 feet to a 50 foot roadway; thence Southwesterly along a curve to the left with a radius of 863.09 feet a distance of 77.85 feet to the point of tangency; thence Southwesterly along the tangent to said curve a distance of 94.97 feet to a point of curvature; thence Southwesterly along a curve to the right with a radius of 616.51 feet a distance of 27.18 feet; thence Northwesterly a distance of 268.70 feet to a point 198.8 feet North 35 feet East of the Southwest corner of the Northwest ¼ Northeast ¼ Northwest ¼ of said Section 21; thence West 35 feet to the place of beginning, containing 1.462 acres, more or less, in Lake County, Indiana.

3. That Jane M. Schuett and Wallace C. Schuett, were Husband and Wife at the time they acquired title to the above-described real estate and so remained until the death of Wallace C. Schuett on November 20, 1997 and they were never divorced.

4. Wallace C. Schuett died on November 20, 1997, that all expenses and taxes incurred in connection therewith have been paid in full and that there are no unpaid bills left by reason of his death.

5. Under the terms of the Trust, at the time of transfer of title to the real estate into the Trust, the Trustee and Successor Trustees designated therein, in the order in which they were to serve, were:



- a. JANE M. SCHUETT, KENNETH J. SCHUETT and JAMES W. SCHUETT, Jointly, Severally, or the Survivor

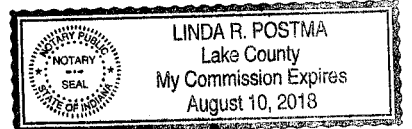


