PERMANENT RESTRICTIVE COVENANT BY MUNSTER PARKS AND RECREATION DEPARTMENT OF THE TOWN OF MUNSTER, INDIANA

FOR VALUE RECEIVED, which value is acknowledged by the Board of Parks and Recreation of the Town of Munster, Indiana ("the Park Board"), the Park Board does hereby GRANT, IMPOSE and PERPETUATE a permanent restrictive covenant on the property legally described in Exhibit A attached hereto, and drawn in Exhibit B attached hereto (the "Property") restricting the use of the Property exclusively for public outdoor recreation, in perpetuity.

The Property described in Exhibit A and Exhibit B was developed with a grant made under the Land and Water Conservation Fund Act of 1965 (Public Law 88-578; 78 Stat. 897 ("LWCF"), which provides that property developed with LWCF assistance shall be retained and used for public outdoor recreation in perpetuity. The property developed shall not be wholly or partly converted to any use other than public outdoor recreation uses without the approval in writing the Indiana Department of Natural Resources and the U.S. Department of the Interior, the latter having the ultimate authority to disapprove conversion requests and/or reject proposed property substitutions.

This easement is subject to the LWCF regulations which, among other provisions, specify that all future utilities constructed or renovated on the property site shall be installed underground, with which regulation the Park Board states to the Indiana Department of Natural Resources it will comply. Any future utility lines which do not serve the area shall also require approval by the Indiana Department of Natural Resources. The Park Board understands and agrees that the provision of Section 6 (f)(3) of the LWCF Act apply in perpetuity, and thus shall continue with the restrictive covenant even after any LWCF assisted facilities have served their useful lives and been discontinued.
