LEGAL DESCRIPTION

Part of the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 29, Township 36 North, Range 7 West of the 2nd Principal Meridian in the City of Hobart, Lake County Indiana described as follows: Beginning at a point on the East line of Michigan Street which is 179.05 feet Northeasterly as measured along the East line of said Street, from the Northwest corner of Lot 16 in the Wood's Addition to Hobart; thence East 291.20 feet to a point on the East line of said $\frac{1}{4}$ Section which is 178.04 feet North of the Northeast corner of said Lot 16; thence North along the East line of said $\frac{1}{4}$ Section 103.34 feet; thence West 278.3 feet to a point on the East line of Michigan Street which is 104.05 feet Northeasterly of the point of beginning; thence Southwesterly along the East line of Michigan Street 104.05 feet to the point of beginning, in Lake County Indiana, EXCEPT the East 141.2 feet thereof.
