UNITED STATES MARSHAL'S DEED

THAT WHEREAS, at a regular term of the District Court of the United States, held in and for said District, South Bend Division, on the 8th day of June, 2010, said Horizon Bank, N.A., recovered a summary judgment against Kolo Dining II, LLC, Kolo Realty II, LLC, Lori B. Long and Lance E.
