**MEMORANDUM OF AMENDMENT OF THE
BECKER LIVING TRUST and AFFIDAVIT OF SURVIVORSHIP**

1. On June 14, 2005, we Restated our Trust, known as the Becker Living Trust, "Trust", which was originally executed on October 10, 2000. Since said time, Robert L. Becker passed away on May 11, 2008. Thereafter on September 21, 2010, I amended our Trust.

2. In reliance upon the terms and conditions of our original Trust, the following described real estate was transferred into the name of the Trustees of the Trust, to-wit:

Lot 307, Briarwood Unit 14, in the City of Crown Point, as shown in Plat Book 64, page 6, Lake County, IN. Key No.45-16-16-201-006.000-042 AND
Lot 1096, Lakes of the Four Seasons, Unit No. 7, as per plat thereof, recorded in Plat Book 38, page 9, in the Office of the Recorder of Lake County, IN Key No. 45-17-16-178-008.000-044

3. Under the terms of the Trust dated June 14, 2005, the Trustee and Successor Trustees designated therein for Judith A. Becker, in the order in which they were to serve, were:

- A. Current Trustee:
 - a. Robert L. Becker and Judith A. Becker
- B. Successor Trustees:
 - In the event Judith A. Becker is unable to so act:
 - a. Robert L. Becker
 - b. Bruce E. Turner
 - c. William A. Becker

4. Under the terms of the Amendment of Trust, known as the Becker Living Trust, dated October 10, 2000, and Restated on June 14, 2005, the Trustees and Successor Trustees for Judith A. Becker, designated therein, in the order in which they are to serve, are:

- A. Current Trustee:
 - a. Judith A. Becker
- B. Successor Trustees:
 - a. Bruce E. Turner
 - b. Garry Aloia
 - c. William A. Becker
