RELEASE AND TERMINATION OF EASEMENT

THIS RELEASE AND TERMINATION OF EASEMENT ("Termination") is made and entered into this 04 day of MAY, 2010, by **Wide Open West** ("WOW").

WHEREAS, the City of Hammond Redevelopment Commission filed a petition with the Common Council of the City of Hammond, Lake County, Indiana, requesting the vacation of that a portion of remnant Moss Street and adjacent public alleys lying east of Columbia Avenue and south of Field Street which is commonly known as Columbia Avenue Business Park and legally described as:

Parcel "1"

Part of the Southeast Quarter of Section 6, Township 36 North, Range 9 West of the Second Principal Meridian, being more particularly described as follows:

WHEREAS, by Ordinance Number 8426 of the Common Council of the City of Hammond, Lake County, Indiana, the Common Council duly passed an ordinance to vacate the above-described portion of Moss Street and adjacent public alleys lying east of Columbia Avenue and south of Field Street ("Vacated Moss and Alley") on June, 25, 2002. Said vacation is certified by the Certification of the City Clerk of the City of Hammond, Lake County, Indiana as recorded on July 9, 2002 as Document Number 2002 060874 in the County Recorder's Office of the Lake County, Indiana, attached hereto as Exhibit A; and

WHEREAS, upon the vacation of Vacated Moss and Alley, WOW retained easement rights within Vacated Moss and Alley (the "Road Easements"); and

WHEREAS, the Columbia Avenue Business Park (a Planned Unit Development) Final Plat of P.U.D. Phase 2; Lots 2, 3 and 4 and Outlot B addition to the City of Hammond, Lake County, Indiana, a Resubdivision of property including Hawkins addition and Block 1 and Block 2 of Hawkins 2nd Addition, as recorded on Document Number 2003 092031 in Plat Book 94 on Page 27 in the County Recorder's Office of the Lake County, Indiana, (the "Plat") granted a ten (10) foot utility easement and a fifteen (15) foot utility easement along Lot 4 of the Columbia Avenue Business Park addition to the City of Hammond, ("Plat Easements") as depicted in on the Plat attached hereto as Exhibit B; and

WHEREAS, Menard is the successor in interest to the City of Hammond and is owner of the parcel of land more particularly described in Exhibit C, (the "Menard Parcel"), which parcel includes the areas of the Road Easements and the Plat Easements; and

WHEREAS, to accommodate the redevelopment of the Menard Parcel, WOW desires to release and terminate any and all easement rights it retained in the Road Easements and Plat Easements.

NOW, THEREFORE:

1. Termination.

- A) WOW hereby terminates the Road Easements and Plat Easements, and forever relinquishes and releases any rights it may have pursuant thereto.
- B) WOW hereby releases Menard from any and all obligations pursuant to the Road Easements and Plat Easements.
- C) It is the intent of WOW that, from and after the execution of this Termination, the Road Easements and the Plat Easements shall no longer burden, benefit or otherwise affect the Menard Parcel or any portion thereof.

2. Miscellaneous.

- A) This Termination is binding upon WOW and shall inure to the benefit of WOW and Menard and their respective successors and assigns.
- B) This Termination shall become effective as of the date WOW has executed this Termination.

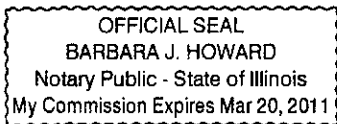

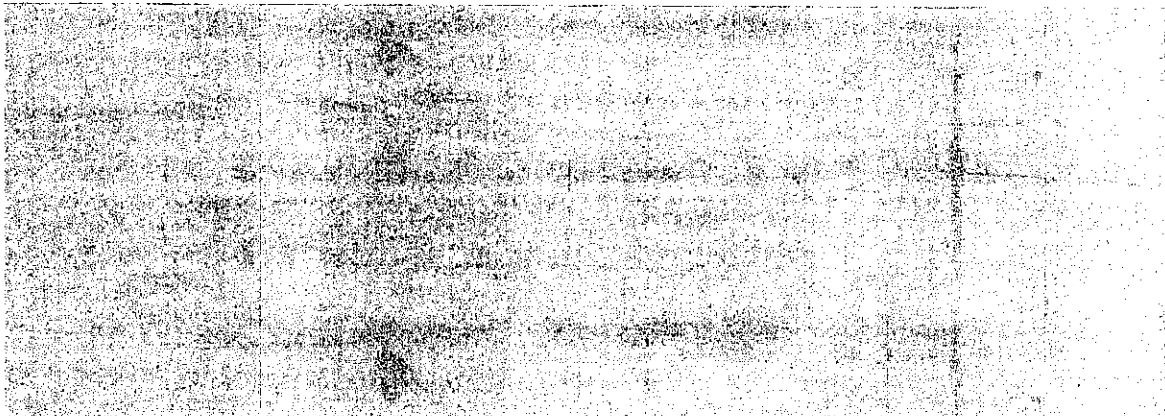

WHEREAS, the vacation will not make access to the lands of any persons difficult or inconvenient; and

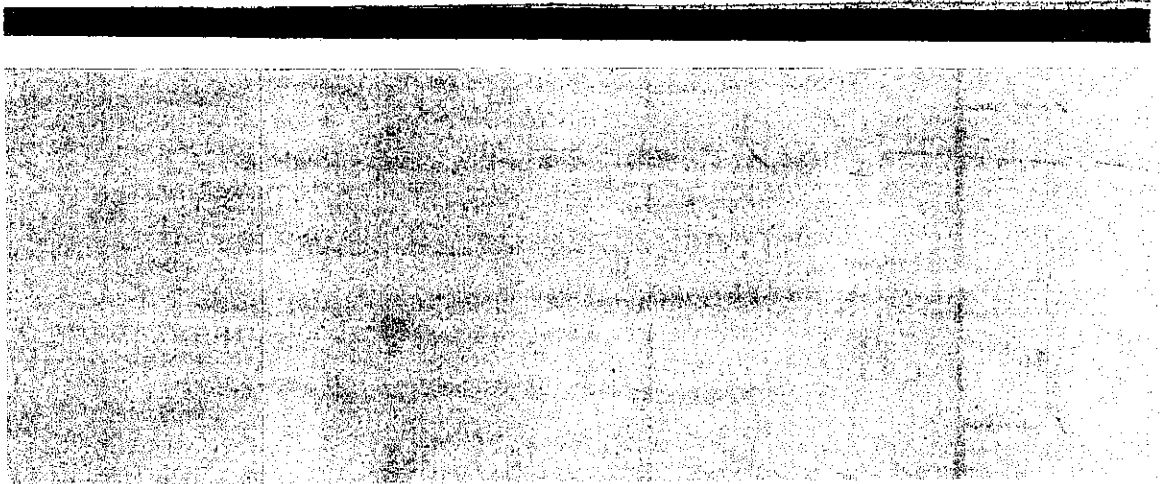
WHEREAS, the vacation will not hinder the public's access to a church, school, or other public building or place; and

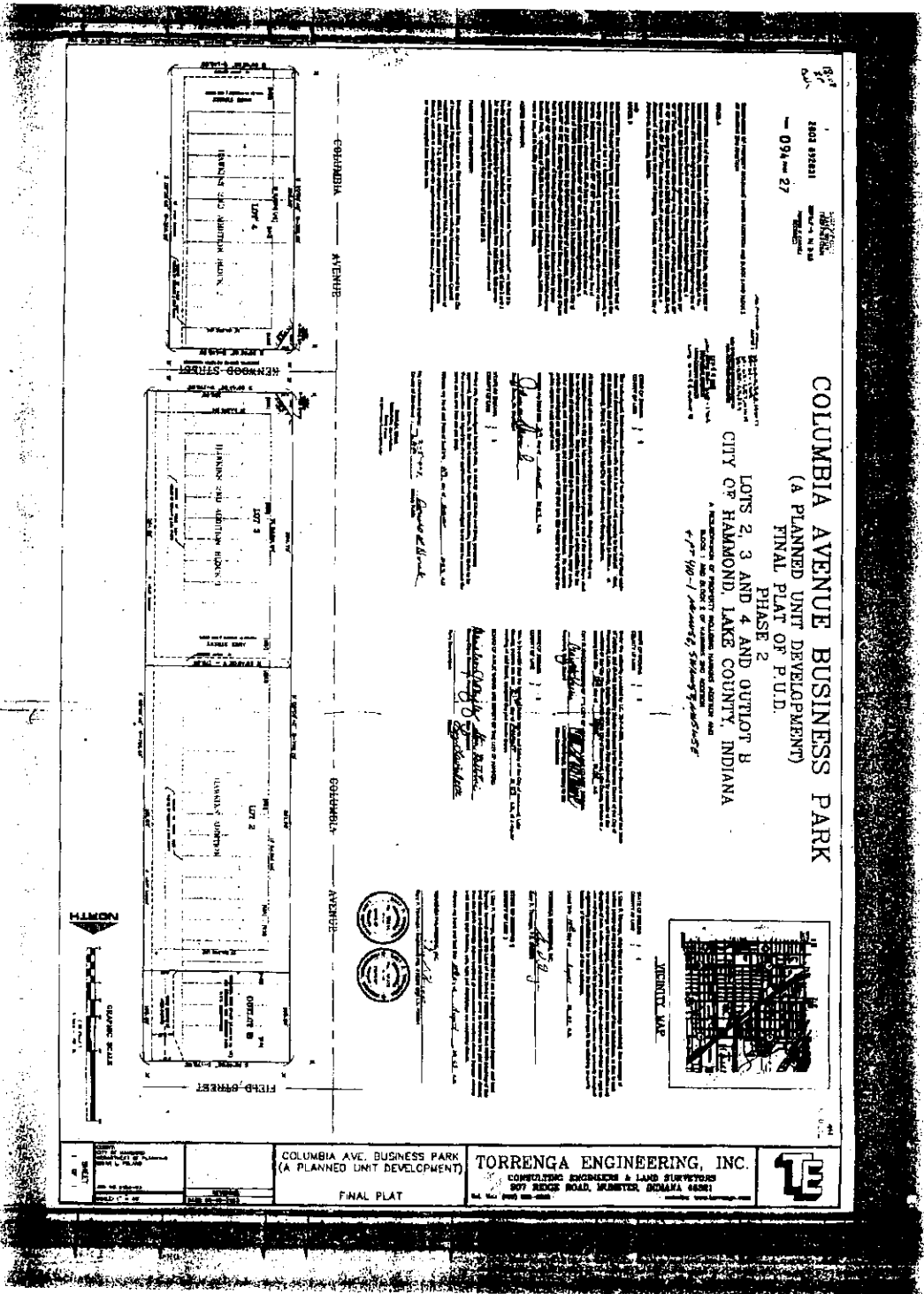

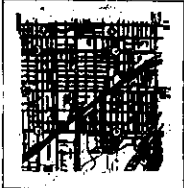
