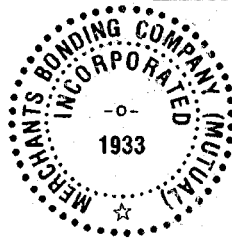

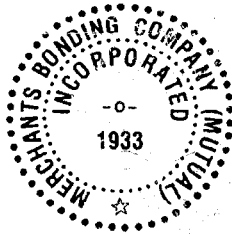
CERTIFICATION
