The Cause is hereby submitted and evidence considered on Plaintiff's Motion.

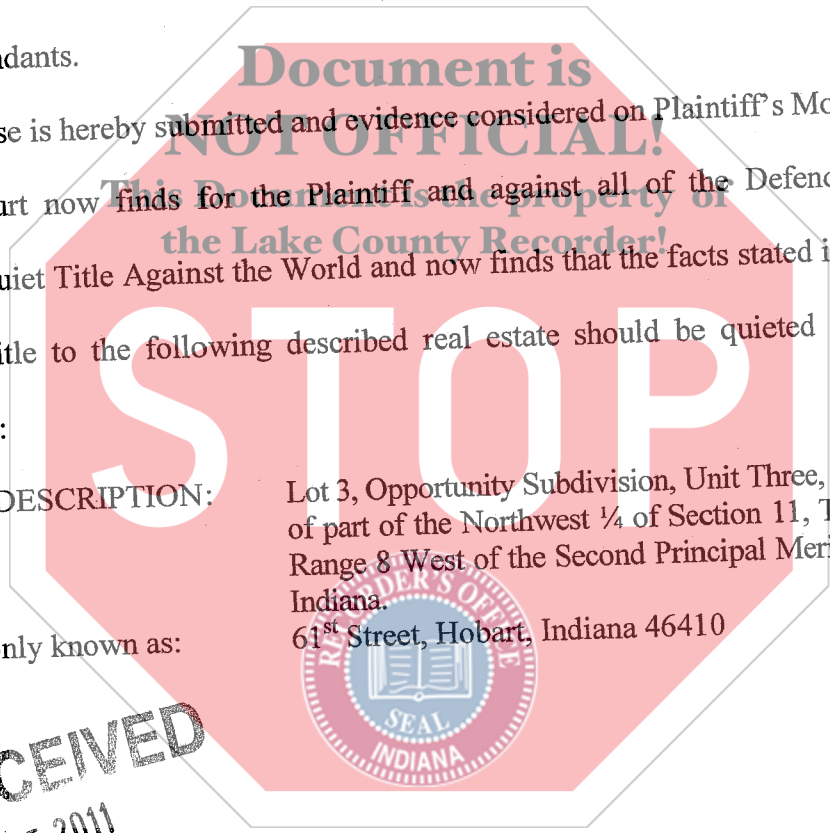
