Lot 25, in The Heritage, as per plat thereof, recorded in Plat Book 96 page 95, in the Office of the Recorder Lake County, Indiana, excepting therefrom the following described Parcel: Beginning at the Northwest corner of said Lot 25; thence North 59 degrees 13 minutes 21 seconds East along the Northerly line of said Lot, a distance of 185.01 feet to the Easterly line of said Lot being the beginning of a non-tangent curve concave to the Northeast having a radius of 105.00 feet and a chord bearing South 38 degrees 22 minutes 47 seconds East, 27.78 feet; thence Southeasterly along said Easterly line and said curve, a distance of 27.86 feet; thence South 43 degrees 55 minutes 42 seconds West, a distance of 245.99 feet to the South line of said Lot; thence South 89 degrees 44 minutes 10 seconds West along said South line, a distance of 4.45 feet to the West line of said Lot; thence North 00 degrees 36 minutes 05 seconds West along said West line, a distance of 104.30 feet to the point of beginning, commonly known as 8494 Marshall Place - South Unit, Merrillville, IN 46410.
