SPECIAL WARRANTY DEED

THIS INDENTURE WITNESSETH THAT

CONVEY(S) AND WARRANT(S) TO

WHHTTP, LLC, for Ten Dollars and other valuable consideration the receipt whereof is hereby acknowledged, the following described REAL ESTATE in Lake County, in the State of Indiana, to wit:

Grantee shall also be prohibited from encumbering subject property with a security interest in the principal amount of greater than \$9,705.60 for a period of 3 month(s) from the date of this deed. These restrictions shall run with the land and are not personal to the Grantee.

This restriction shall terminate immediately upon conveyance at any foreclosure sale related to a mortgage or deed of trust.

It is understood and agreed by the parties hereto that the title to the real estate herein conveyed is warranted only insofar as it might be affected by any act of the grantor during the grantor's ownership thereof and not otherwise.

This instrument is being executed under the authority granted by a Power of Attorney dated October 21, 2008, and recorded as Instrument No. 2009034819 in the Office of the Recorder of Lake County, Indiana.

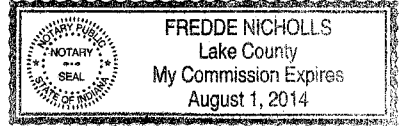
