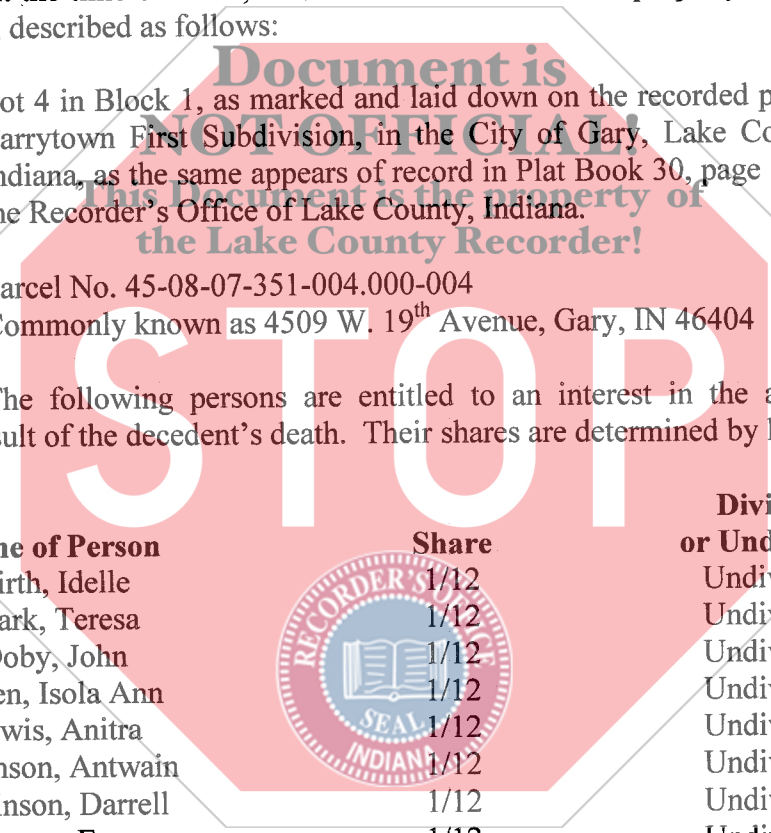
4. At the time of death, the decedent owned the real property located in Gary, Lake County, Indiana, described as follows:


