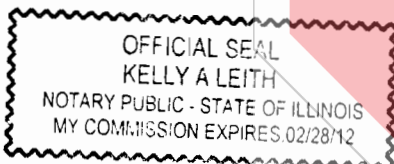

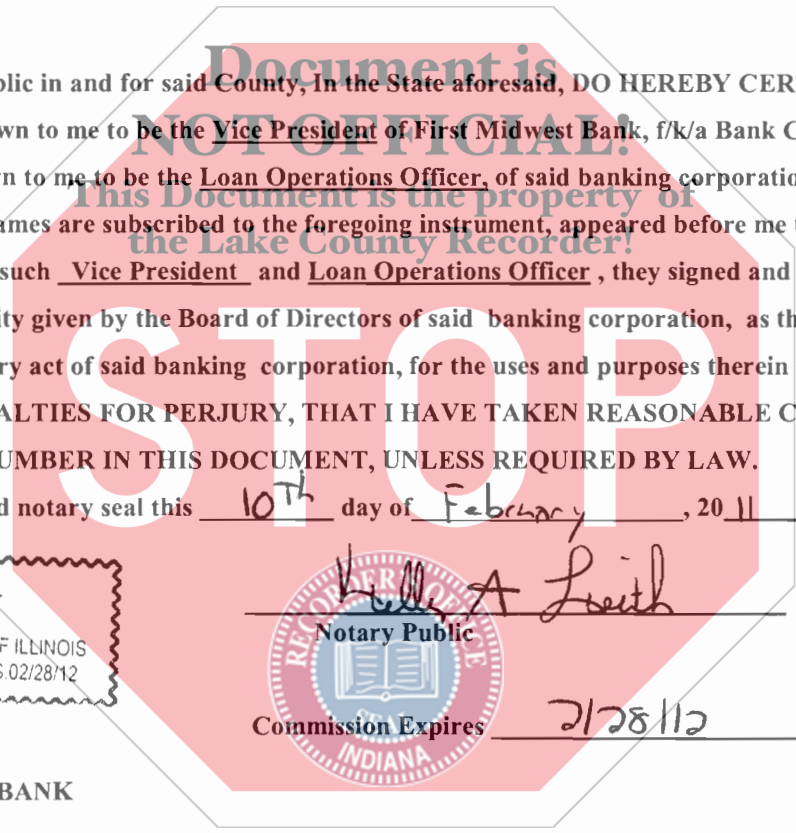


EXHIBIT "A"

THE NORTH 75 FEET OF THE FOLLOWING DESCRIBED TRACT OF LAND: THAT PART OF THE NORTH HALF OF THE NORTHEAST QUARTER OF SECTION 12, TOWNSHIP 35, NORTH RANGE 10 WEST OF THE SECOND PRINCIPAL MERIDIAN DESCRIBED AS COMMENCING AT THE SOUTH LINE THEREOF AT THE POINT OF INTERSECTION WITH THE EAST LINE OF THE CHICAGO, LOUISVILLE AND SOUTHERN RAILROAD CO.
