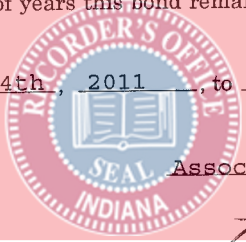
in said Lake County, Indiana, then this obligation shall be void, otherwise to be and remain in full force and effect.
