This bond is for a definite term beginning January 1, 2011, and ending December 31, 2011, and may be continued at the option of the Surety by Continuation Certificate.

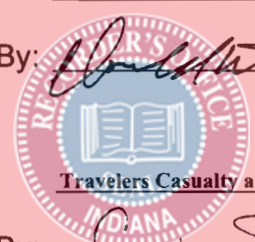

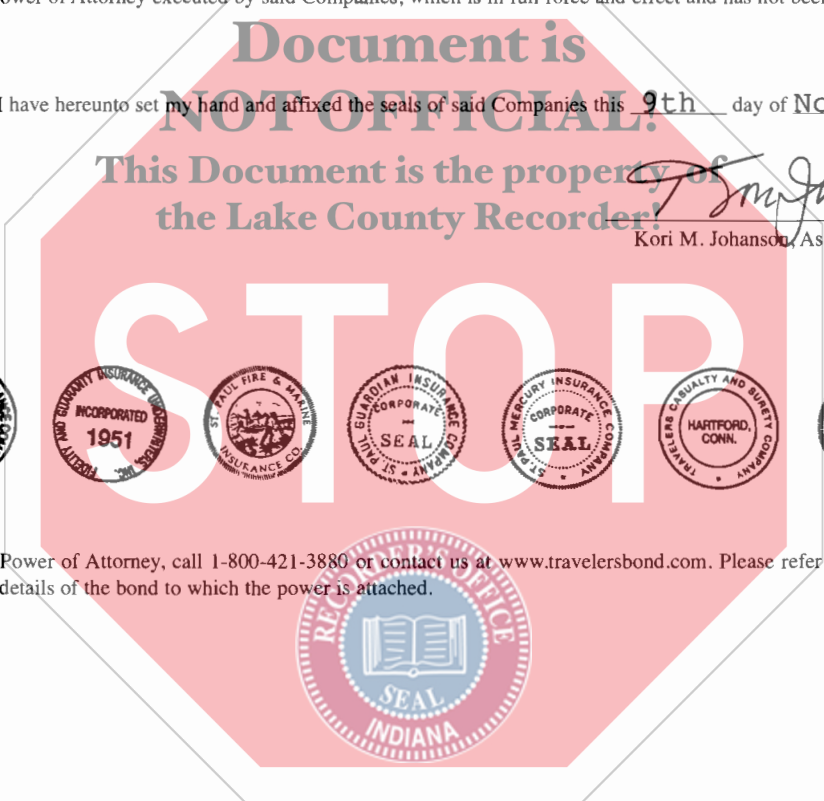
