NOTICE OF SUBROGATION RIGHTS HELD BY

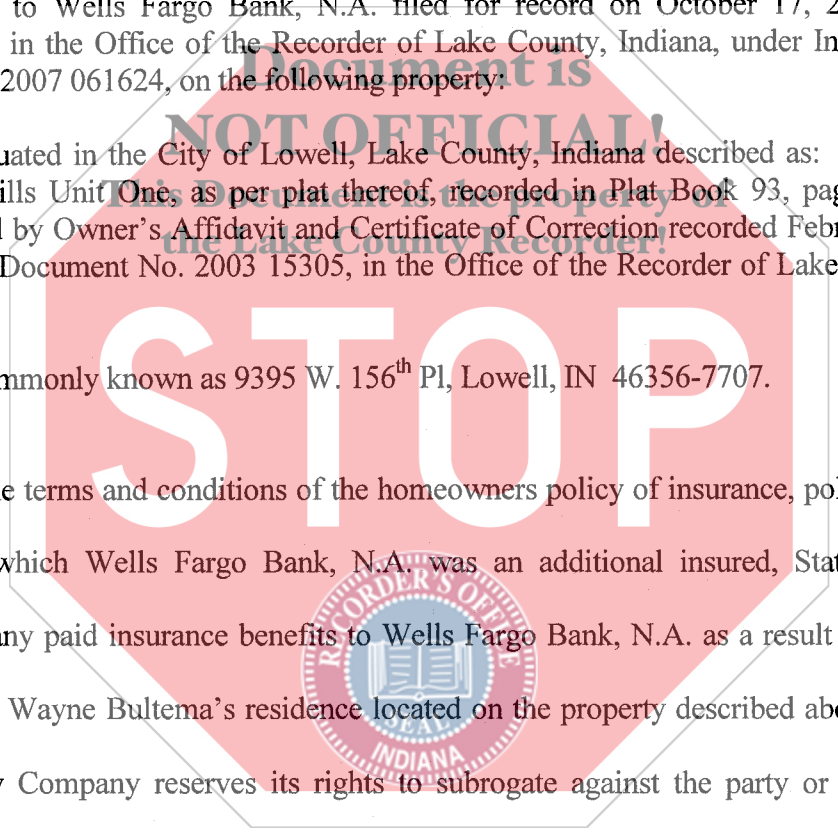

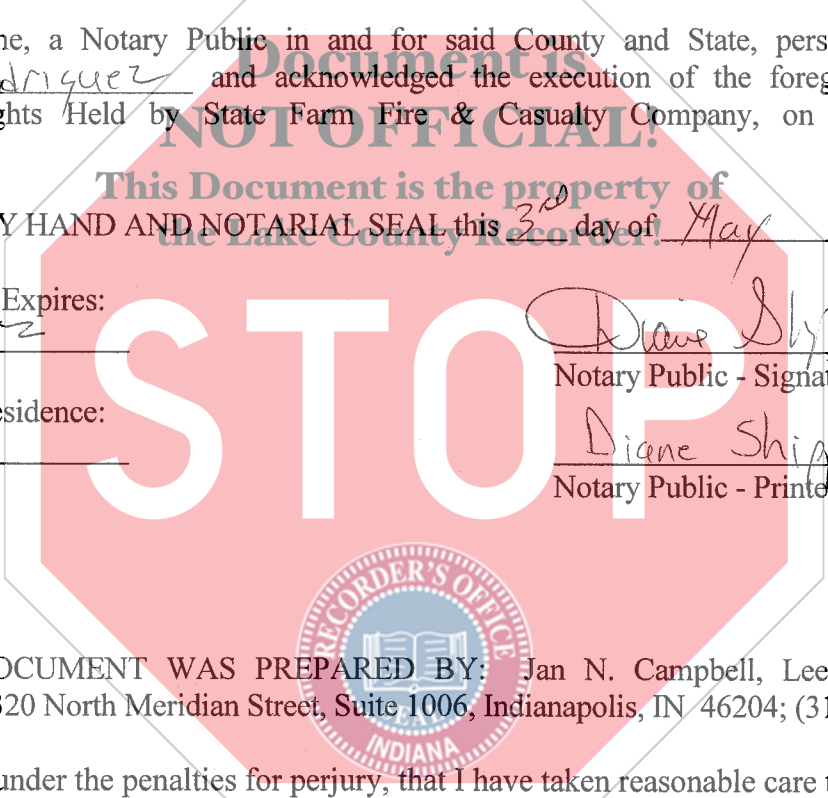
