## **EXHIBIT "A"**

Order No. 620111231

Part of Lot 3, in Victoria Place, an Addition to the Town of Schererville, as per plat thereof, recorded in Plat Book 79, page 90, in the Office of the Recorder of Lake County, Indiana, more particularly described as follows: Beginning at the Northwest corner of said Lot 3; thence South 89 degrees 39 minutes 53 seconds East, along the North line of said Lot 3, a distance of 49.98 feet; thence South 10 degrees 07 minutes 22 seconds West, a distance of 116.48 feet to a point on a curve concave to the Southeast, having a radius of 60.00 feet; thence Southwesterly along said curve (also being the Northerly right-of-way line of Victoria Place), an arc distance of 14.00 feet to the Southwest corner of said Lot 3; thence North 27 degrees 47 minutes 03 seconds West along the Westerly line of said Lot 3, a distance of 60.72 feet; thence continuing along said Westerly line North 10 degrees 07 minutes 22 seconds East, a distance of 67.32 feet to the point of beginning.

Subject to covenants and restrictions, easements and building lines as contained in plat of subdivision and as contained in all other documents of record; and real estate taxes and assessments for 2010 payable 2011 together with delinquency and penalty, if any, and all real estate taxes and assessments due and payable thereafter which the grantee herein assumes and agrees to pay.
