NOT VALID FOR MORE THAN \$25,000.00

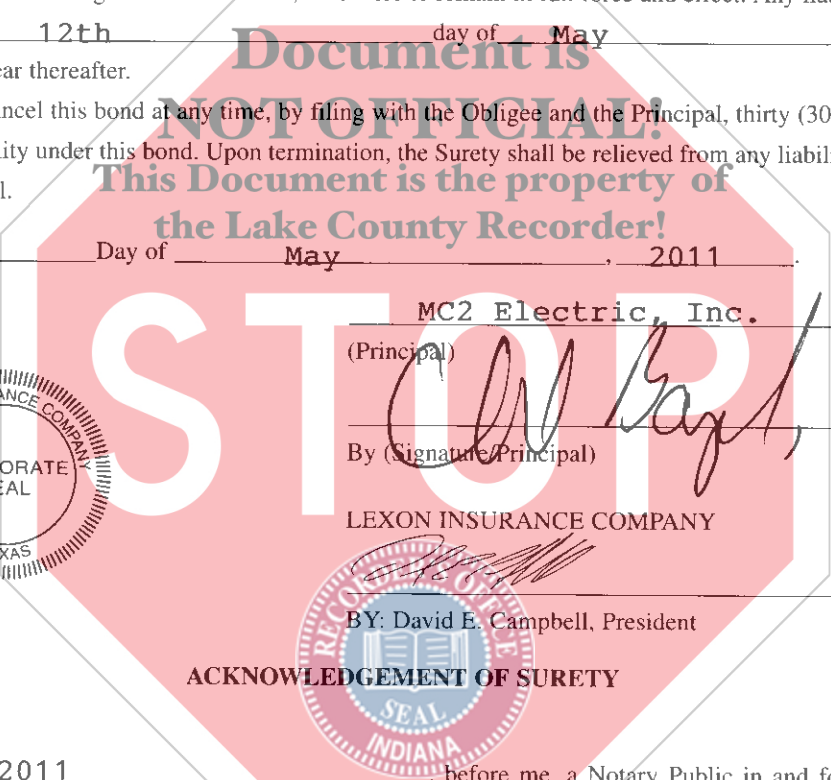

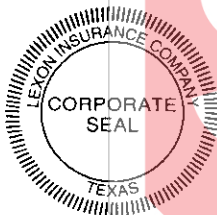

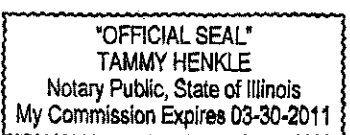
