LIMITED POWER OF ATTORNEY

all in accordance with the Servicing Agreement, as fully, to all intents and purposes, as the Grantee might or could do if present through one of its authorized representatives, with full power of substitution and revocation.

Until a properly executed revocation of this Limited Power of Attorney is duly executed and delivered, all parties dealing with said attorney-in-fact (individually or collectively) in connection with the above-described matters may fully rely upon the power and authority of said attorney-in-fact to act for and on behalf of the undersigned, and in its name, place and stea may accept and rely on all documents and agreements entered tanks to pursuant to the powers listed herein.
