2. That Ruth C. Johansson is the Settlor of the Ruth C. Johansson Revocable Trust u/t/d April 28, 1992.

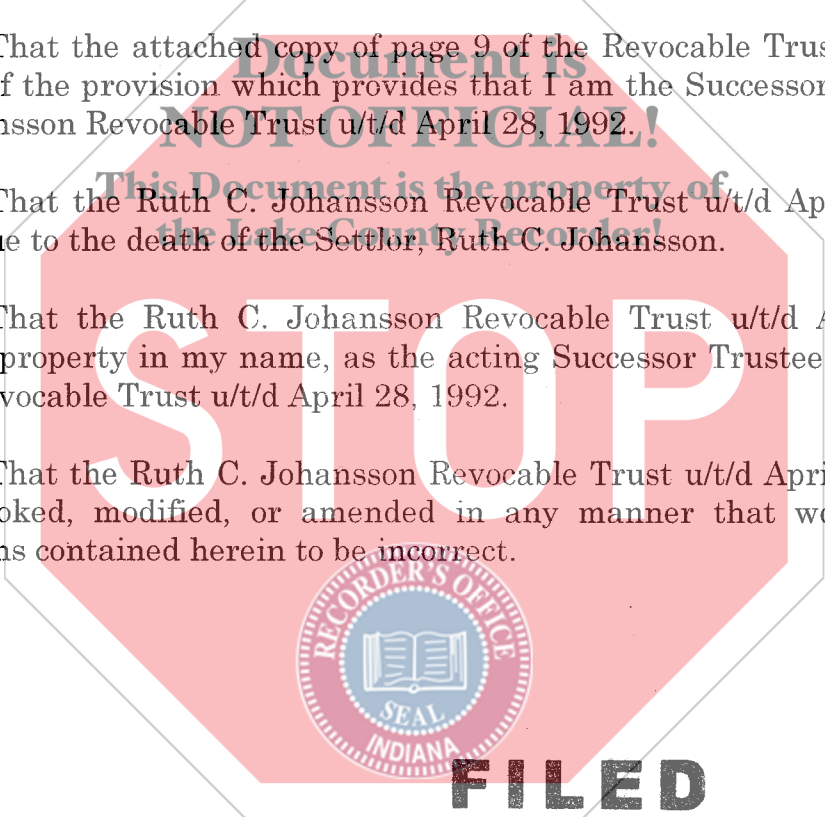
3. That I currently reside at 4849 Van Buren Street, Gary, Indiana 46408.

REVOCABLE TRUST AGREEMENT

SETTLOR: RUTH C. JOHANSSON, AT THE PRESENT TIME A RESIDENT  
OF GARY, LAKE COUNTY, INDIANA

TRUSTEE: RUTH C. JOHANSSON

SUCCESSOR  
TRUSTEE: JOHN R. JOHANSSON

1. NAME OF TRUST AND INITIAL CORPUS. The trust may be referred to as the RUTH C. JOHANSSON REVOCABLE TRUST. I hereby deliver to RUTH C. JOHANSSON, as Trustee, an initial corpus in the sum of Ten Dollars (\$10.00).

2. ADDITIONS TO CORPUS. I may add other property to the corpus of this Trust during my lifetime or by virtue of my Last Will and Testament or otherwise by reason of my death. Such additions to the corpus may include policies of insurance on my life which may not be deposited with the Trustee. The Trustee agrees to accept all additions, including any additions made by the proceeds of insurance policies on my life held by any others. The Trustee may, in her discretion, also accept additions from other persons' estates or parties. All additions, from whatever source, shall be governed by the terms of this agreement and shall be divided and distributed as set out below. Any net sums collected by the Trustee, as the proceeds of insurance on my life, shall be deemed corpus rather than income.

3. INCOME AND PRINCIPAL DURING MY LIFETIME. During my lifetime, the Trustee shall pay to me any net income which the

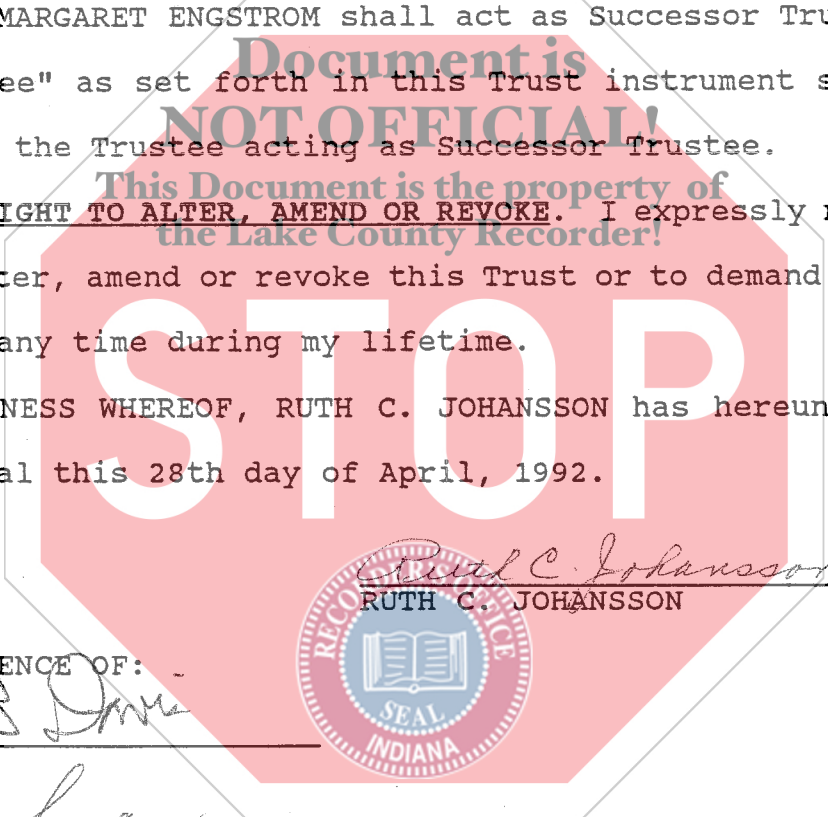
Trustee may reimburse herself for any such advances or costs out of any corpus or income of this Trust.

7. TRUSTEE'S COMPENSATION. My Trustee shall be entitled to compensation which is normally and usually provided for corporate Trustees performing the activities called for in this trust instrument.

8. SUCCESSOR TRUSTEES. Upon the resignation or impairment or incompetence of the Settlor or the death of the Settlor, JOHN R. JOHANSSON, Successor Trustee, shall have all authority to act as Trustee of this Trust. If my son, JOHN R. JOHANSSON, is at any time unable or unwilling to act as Successor Trustee, then and in that event MARGARET ENGSTROM shall act as Successor Trustee. The term "Trustee" as set forth in this Trust instrument shall refer likewise to the Trustee acting as Successor Trustee.

9. RIGHT TO ALTER, AMEND OR REVOKE. I expressly reserve the right to alter, amend or revoke this Trust or to demand the corpus thereof at any time during my lifetime.
