ASSIGNMENT AND ASSUMPTION OF RIGHT OF FIRST REFUSAL



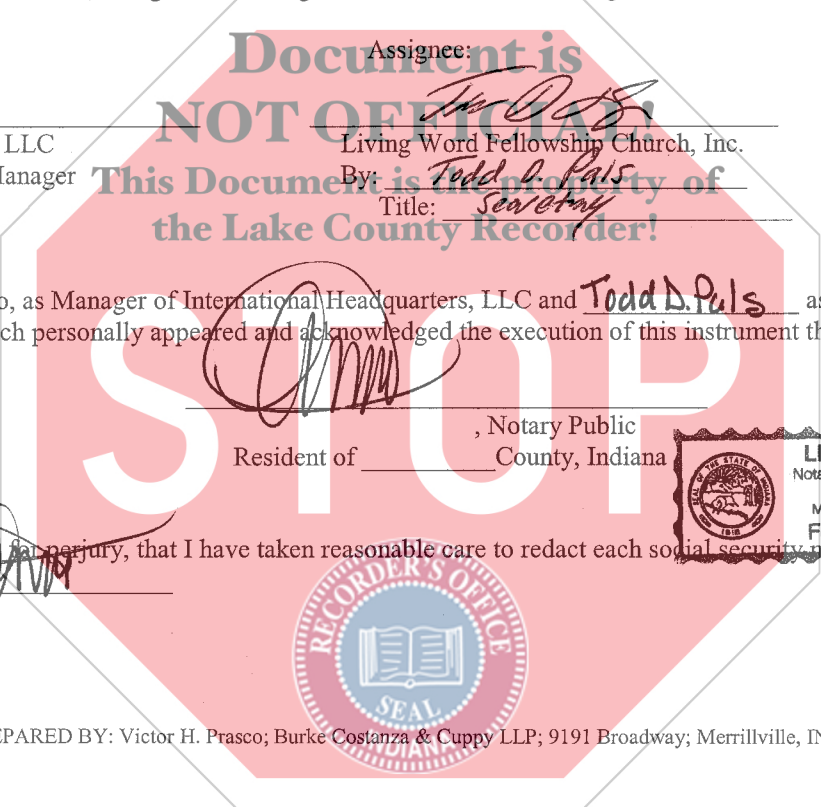
