Comes now DIANE M. DONAHUE f/k/a DIANE M. ROBERTSON, Mother and former Wife in the above-captioned matter who states as follows:

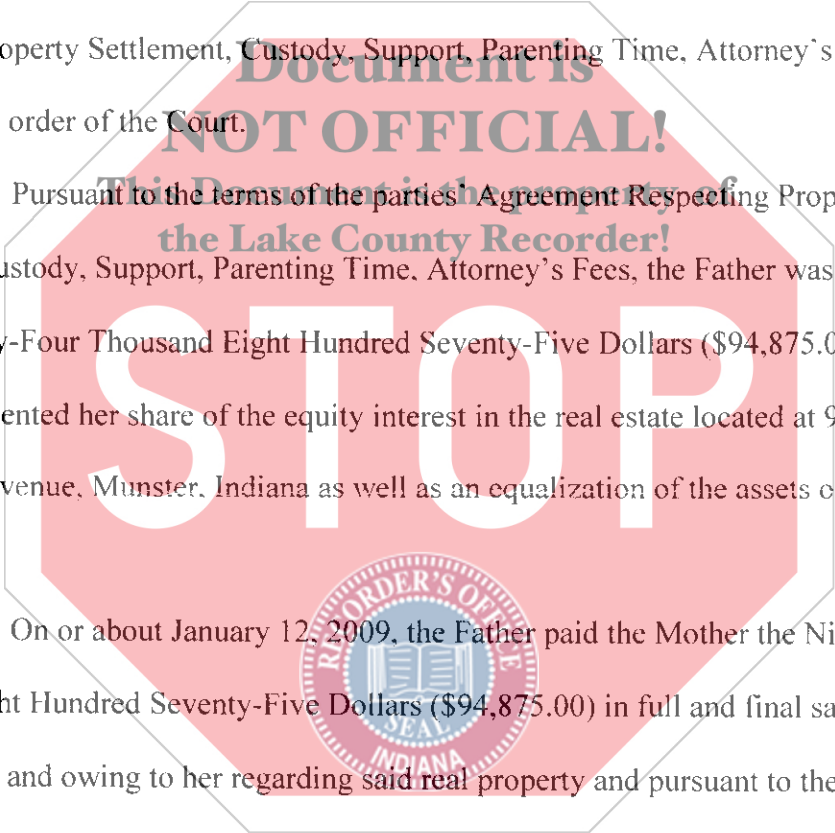


