EXECUTOR'S VERIFIED CLOSING STATEMENT
TO CLOSE ESTATE UPON COMPLETION OF ADMINISTRATION

Comes now Robert Gabrys, as Executor, of the Estate of Elizabeth Gabrys, deceased, who having been duly sworn upon his oath alleges as follows:

1. That on the 18th day of March 2009, the decedent herein died testate, domiciled in Lake County, Indiana. Thereafter, on the 22nd day of May 2009, her Last Will and Testament dated the 10th day of January, 1994, and First Codicil dated March 5, 1998 was duly admitted to probate by this Court.
2. That your Petitioner was appointed Executor of the decedent's estate on the 22nd day of May 2009, and letters testamentary were issued to him on that date and said Petitioner was authorized to proceed under the provisions of the Indiana Code governing unsupervised estates.
3. That notice of his appointment as personal representative of the Estate of Elizabeth Gabrys was first published to creditors on the 9th day of June 2009, in the *Lowell Tribune* and that five (5) months have elapsed since the first published notice to creditors.
4. That the Petitioner has fully administered the estate of the decedent, in that he has collected all the assets of the estate, that have come to his knowledge, filed all required Federal Estate and Income Tax Returns, Indiana Income and Inheritance Tax Returns, and paid all taxes.
5. That no claims were filed in the decedent's estate.
6. That all the assets of said estate have been administered upon and no reason exists why this estate cannot be closed at this time. That said Petitioner has forwarded a copy of his accounting which is attached hereto and marked as Exhibit "A" and made a part of this closing statement to all legatees, devisees and distributees said closing statement shall serve as notice upon said distributees of their respective interest in the decedent's estate.
7. That the decedent died owning a 100% fee simple interest in the following parcel of real estate located in Lake County, Indiana, of which no sale or other disposition was made during the period of this administration. Said real estate more specifically being described as follows:
