

on the following described real property located in Lake county, State of Indiana, commonly known as:



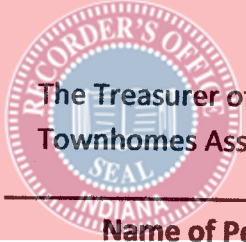
