MODIFICATION OF MORTGAGE

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

GRANT OF MORTGAGE. The Real Property located in Lake County, State of Indiana.

GOVERNING LAW. With the respect to procedural matters related to the perfection and enforcement of Lender's rights against the Property, this Mortgage will be governed by federal law applicable to Lender and to the extent not preempted by federal law, the laws of the State of Indiana. In all other respects, this Mortgage will be governed by federal law applicable to Lender and, to the extent not preempted by federal law, the laws of the State of Illinois without regard to its conflicts of law provisions. However, if there ever is a question about whether any provision of this Mortgage is valid or enforceable, the provision that is questioned will be governed by whichever state of federal law would find the provision to be valid and enforceable.
