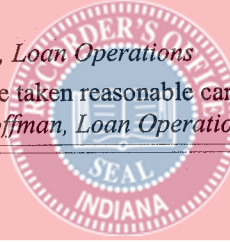
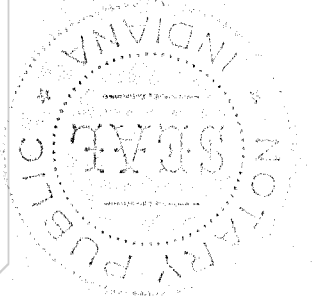

LEGAL DESCRIPTION

Parcel I:

A part of the Southwest Quarter of the Southwest Quarter of Section 10, Township 35 North, Range 8 West, of the 2nd P.M., described as follows: Beginning at a point 220 feet North and 195 feet East of the Southwest corner of said Section 10, thence East parallel to the South line of said Section 60 feet; thence North 100 feet parallel to the West line of said Section; thence West 60 feet parallel to the South line of said Section; thence South 100 feet parallel to the West line of said Section to the place of beginning, in Lake County, Indiana.

Also:

A part of the Southwest Quarter of the Southwest Quarter of Section 10, Township 35 North, Range 8 West of the 2nd P.M., in Lake County, Indiana, described as follows: Beginning at a point 220 feet North and 255 feet East of the Southwest corner of said Section 10 (said point being the Southeast corner of a parcel of land described in a deed from Lake County Trust Company to Lake County Public Library dated March 20, 1958 and recorded March 21st, 1950 in Deed Record 1082 page 497); thence North parallel with the West line of said Section a distance of 100 feet (being along the East line of the above described deed); thence East parallel with the South line of said Section a distance of 85 feet, more or less, to the West line of Massachusetts Street; thence South parallel with the West line of said Section a distance of 100 feet to a point 220 feet North of the South line of said Section; thence West parallel with the South line of said Section a distance of 85 feet to the point of beginning.
