POWER OF ATTORNEY

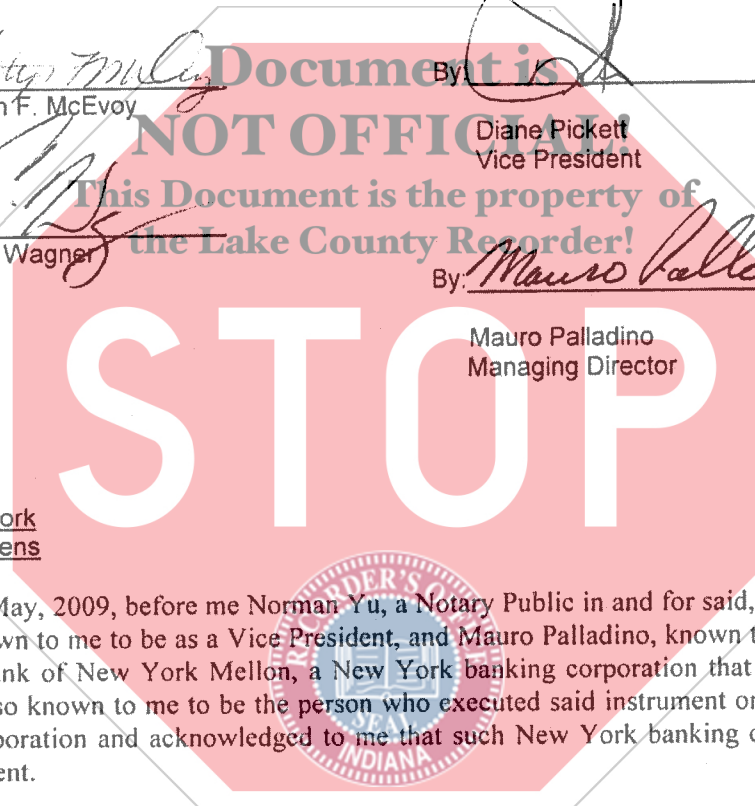
