That to the best of the affiant's knowledge, said Paul E. Sinal, a/k/a Paul Sinal owned the following described real estate at the time of his death:

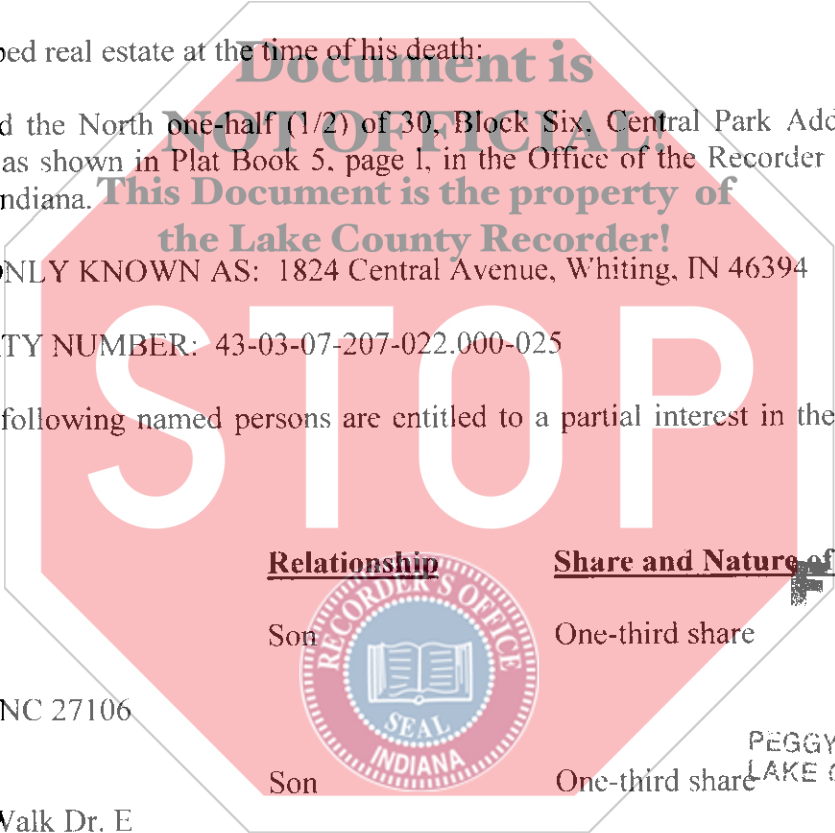
