**WHEREAS,** the Principal has obtained or is about to obtain a license or permit for City of Hobart Contractor's Bond - Carpentry

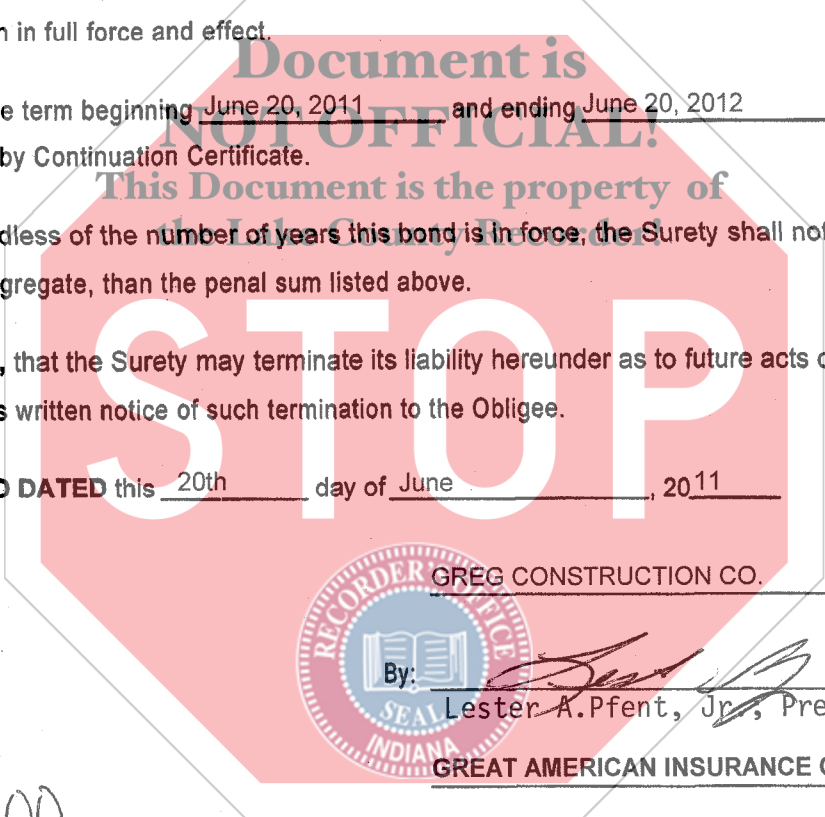
