for a term beginning AUGUST 8, 2011 and ending AUGUST 8, 2012

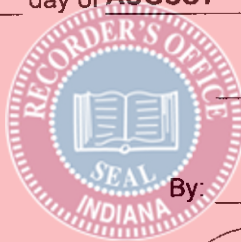
