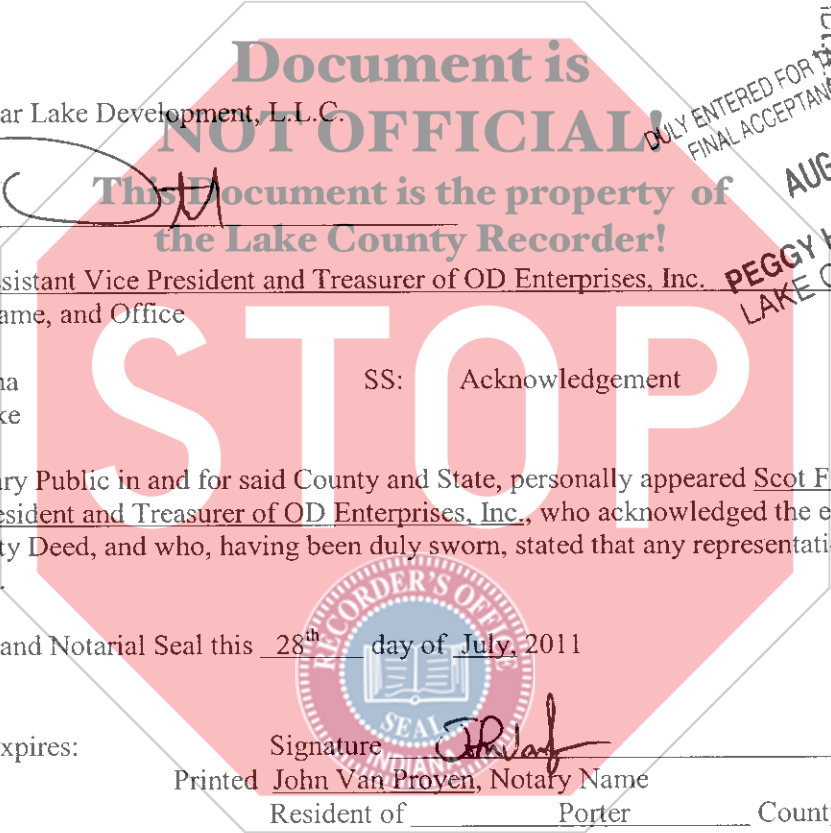

LEGAL DESCRIPTION

Part of Lot 196 in Centennial Subdivision - Phase 2, an Addition to the Town of Cedar Lake, as per plat thereof, recorded in Plat Book 103 page 87, in the Office of the Recorder of Lake County, Indiana., which part of said Lot is described as follows: Commencing at the Northerly most corner of said Lot 196; thence South 37 degrees 32 minutes 57 seconds East, along the Northeasterly line of said lot, 85.50 feet; thence South 52 degrees 27 minutes 03 seconds West, 34.72 feet; thence South 85 degrees 00 minutes 18 seconds West, 48.96 feet to the Southwest corner of said Lot 196; thence North 04 degrees 59 minutes 42 seconds West, along the West line of said Lot, 131.45 feet to the Northwest corner of said Lot; thence Easterly along the curved Northerly line of said Lot, 24.86 feet; thence South 37 degrees 32 minutes 57 seconds East, 113.09 feet to the point of beginning.
